Tables/chairs: Please let us know if you need to rent tables and chairs from us. I need Tables Chairs

Insurance: All vendors must carry commercial liability insurance, fill out the attached form and provide an insurance certificate per the instructions on the form.

Policies: No Booth Splitting. Vendor banners are only permitted on the fence behind your booth, or the railing above your booth. Sponsors have priority on railing space. Only vendor/sponsor banners are permitted. Drones are *strictly* prohibited. Porsche dealerships may only participate at a sponsorship level.

Note: This is a Rain or Shine Event. The Fontana area is subject to very high winds. All booths and coverings must be securely tied down. No refunds for weather related issues.

EXHIBIT B
Vendor/Subcontractor Insurance and Indemnity Agreement

This Insurance and Indemnity Agreement ("Agreement") is made and entered into as of the last date of execution by a party hereto ("Effective Date"), by and between _____, a _____ company, with offices at _____ ("Vendor") and _____ ("Renter").

1. **Purpose of Agreement.** Vendor is providing goods or services at an event taking place at Auto Club Speedway) ("Speedway") on (insert date) ("Event") conducted by Renter. California Speedway Corporation ("Track") agrees to allow Vendor to enter the Speedway during the Event for this purpose subject to Vendor's compliance with the rules and regulations of the Speedway and the terms and conditions of this Agreement.
2. **Insurance.** Vendor agrees to secure and maintain a commercial general liability insurance policy having a combined single limit of at least One Million Dollars (\$1,000,000) per occurrence, naming California Speedway Corporation, Renter and their respective parent companies, their subsidiaries, limited liability and affiliated companies and their respective shareholders, members, officers, directors, agents, employees, trustees, receivers, successors, and assigns ("Indemnified Parties") as additional insured. Vendor shall also secure the following types of insurance and minimum limits: (1) Automobile Liability Insurance with a combined single limit of One Million Dollars (\$1,000,000) per accident for bodily injury and property damage liability; (2) Worker's Compensation Insurance with minimum limits statutory for all states of operation, including employer's liability with limits of not less than Five Hundred Thousand Dollars (\$500,000). Vendor will provide Renter a copy of vendors' certificate of insurance evidencing the coverage required in this paragraph prior to being granted access to the Speedway. Such insurance shall be primary and non-contributory to any other insurance that may be available to the Indemnified Parties and provide a waiver of subrogation in favor of the Indemnified Parties. Should the above described policy(ies) be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions.
3. **Indemnification.** Vendor shall indemnify, defend and hold the Indemnified Parties harmless from and against any and all liability, loss, damage, expenses, court costs and attorneys' fees in connection with, arising out of or directly or indirectly, related to (i) any claim of loss or damage to property or of death or injury to persons, resulting from use of the products or services of Vendor; (ii) any claim of damage resulting from the acts or omissions of Vendor, its respective agents, employees, contractors or subcontractors, or (iii) any claim of damage resulting from the breach of this Agreement by Vendor. Vendor's obligations hereunder to defend shall extend to claims alleging the sole negligence, willful misconduct or violation of law of an Indemnified Party when combined with other claims triggering Vendor's obligation to indemnify, provided however that upon the final adjudication by a court of competent jurisdiction or written settlement between the parties, Vendor shall be reimbursed for the portion of fees or losses so adjudicated as the responsibility of an Indemnified Party.
4. **Third Party Beneficiary.** Vendor and Renter agree that Track, as the owner or leaseholder of the property where the Event will be held, is an intended third party beneficiary and has the right to enforce the terms and conditions of this Agreement.

Each of the individuals executing this Agreement certifies that he or she is duly authorized to do so.
