 - There are two Judge's school in 2024

- Series participants must attend 51% of the Concours to compete or be eligible for end-of-the-year awards and participate in
 - 4 local Concours, or
 - 2 local Concours and one out-of-state Concours
- Concours head judges must submit Concours reports to Dave Witteried who will be tracking judge's points
- Participating regions agreed to split the costs of the end-of-the-year trophy costs
- A restaurant will be agreed up for a 'no-host' celebration to present the trophies
- Regions were asked to continue submitting inserts to the Pano
- There is a typo on the agenda
 - June 24th is the next President's meeting, there will be no meeting in May
- Steve Doll from the Santa Barbara Region advised the presidents of a raffle SBR was having with many prizes; selling each ticket for \$100 for a total of 200 tickets to be sold see attached flyer for details

 June meeting to select the venue and date
