- PCA's Board of Director's Meeting is scheduled for February 23, 2026
 - Presidents were reminded to call in to ensure there will be a quorum
- Regions should be completing their Continuity / Region Reports by the end of the year
- National Award nominations are due the end of the month. If you have any questions, you may call Liz Shaw
- There was discussion regarding the escalating costs of tracks
 - In some cases, the costs have increased so dramatically that some regions are canceling their track days
 - Regions are encouraged to work together to determine if partnering with other regions will help offset some of the costs
- PCA has paid out ~\$150K in subsidies and have announced additional subsidies available to regions:
 - There are now two (2) new Member Socials available for a subsidy of \$500 ea
 - A brand-new subsidy for electric vehicles for a subsidy of \$250

- Regions were reminded if any changes are made to their Bylaws, all changes must be processed and approved through PCA National
 - As a rule of thumb, Bylaws should be reviewed by the regions ~every five (5) years
- There is a membership focus webinar on PCA.ORG which is very informative and helpful on how to sign up juniors, co-members, etc.
 - Regions are encouraged to advise their primary members to sign up a co-member
- Membership: Overall, Palm Springs is the #2 Factored and Vineyard is #6 Factored
- There are six (6) Zone 8 End-of-the-Year Concours winners. As previously agreed to, the eight regions who hosted a Concours will be receiving an invoice to share in the expense of the winner's trophies
 - The no-host lunch for the six (6) winners is expected to be held in January or February
- The in-person president's meeting is scheduled for January 24, 2026 at 9:00 a.m. at Woodland Hills Porsche
